# Farmaè acquires 100% of Valnan S.r.l.

*Viareggio*, 23 April 2020 – **Farmaè S.p.A.** – company listed on the AIM Italia market of Borsa Italiana, leader in Italy in the *e-retailing* of health and well-being products – announces that it has acquired, on today's date, the entire share capital of the digital agency Valnan S.r.l. ("**Valnan**") from the sole shareholder Riccardo lacometti.

Valnan is a communication and *on-line marketing agency*, with registered office in Viareggio, founded in 2003.

The company offers advisory services on the Italian and international markets in the Digital sector, through the activities of 4 units integrated in Digital Consulting, Digital Advertising, Digital Tech and eCommerce. It closed 2019 with turnover of Euro 1,929,290, EBITDA of Euro 103,403 and Profit of Euro 10,381; it shows a Net Financial Position of Euro 311,737.90. Among its current customers, it boasts a *leading position* in the Cosmetics, *Tech, Wine*, Agri-food, Services sectors, etc.

Farmaè has collaborated with Valnan from the beginning of its business and continues to do so for the management of all the institutional and on-line communication activities on the main *digital media* platforms, search engines and *social media*, by planning the necessary investments for enhancing and improving the perception of the *brands* and the products by the end customers and optimising the budgets allocated for *online* advertising activities by using innovative techniques and methods.

The acquisition allows Farmaè to integrate Valnan's business intelligence within its perimeter and benefit from an in-depth overview of e-commerce guaranteed by Valnan's independence on market, which, thanks to the entry in Farmaè's perimeter, may be able, vice versa, to benefit from quicker development in the Italian on-line marketing landscape.

The purchase price - amounting to Euro 1,200,000.00 determined on the basis of the valuation carried out by an independent expert appointed by Farmaè - was paid in full on today's date to Riccardo lacometti, from its own resources.

The terms and conditions of the transaction - also functional for the fulfilment by Valnan's sole shareholder, of the commitment, assumed previously, to repay the existing debt of Bewow Srl to Farmaè - are governed by a purchase/sale contract signed on today's date between Farmaè and Riccardo lacometti. This transaction also qualifies as a related-party transaction - given the sole shareholder of Valnan is also a majority shareholder, as well as the Chairman and Chief Executive Officer of Farmaè - and, in particular, as a transaction of "lesser importance" pursuant to the Procedure for Transactions with Related Parties adopted by Farmaè. For this reason, the transaction was approved by Farmaè's Board of Directors (as related-party transaction committee) based on Farmaè's interest in carrying out the transaction, as well as on the cost-effectiveness and substantive correctness of the relevant conditions.
