FARMAÈ GROUP: RESULTS CONTINUE TO GROW IN THE TWELVE MONTHS

PRO-FORMA 2021 GROUP REVENUES OF 108.5 MILLION EUROS (+17%)
AND ONLINE VISITORS TO ALMOST 44 MILLION (+47%)
CONFIRMING THE ABSOLUTE LEADERSHIP OF THE GROUP ON THE MARKET

FOURTH-QUARTER REVENUES AT 27.2 MILLION EUROS, UP 49%.

Viareggio, 17 February 2022 – **Farmaè S.p.A.** – company listed on the **Euronext Growth Milan** market of Borsa Italiana, leading integrated platform in Italy in the healthcare, beauty and wellness sectors – approved the unaudited fourth quarter 2021 revenue figures and key KPIs.

In the fourth quarter of 2021, Group revenues amounted to **27.2 million euros** with an increase of **49%** compared to the 18.3 million euros recorded by Farmaè S.p.A alone in the fourth quarter of 2020, already positively impacted by the lockdown in October and November. This growth is also confirmed on a twelve-month basis in 2021 with consolidated revenues equal to **85.9 million euros**, including AmicaFarmacia S.r.l. limited to the last three months of 2021, with an increase of **31%** compared to 65.5 million euros recorded in the twelve months of 2020 (pre-acquisition AmicaFarmacia S.r.l.).

Pro-forma Group revenues for the full year 2021, deriving from the combination of Farmaè S.p.A. and AmicaFamacia S.r.I., amounted to **108.5 million euros, up 17%** on 2020 pro-forma revenues of 93 million euros.

The Group's main KPIs continue to improve significantly, on a like-for-like basis in terms of revenue consolidation.

In fact, customers on the Group's portals grew by **32%** in the fourth quarter to approximately **333** thousand compared to 253 thousand in the same period of 2020, with orders on the platforms increasing from 411 thousand recorded in the fourth quarter of 2020 to 507 thousand recorded in the fourth quarter of 2021. For the full year 2021, orders fulfilled totaled **1.7 million** with growth compared to 2020 of 18%.

In 2021, the total number of visitors on online platforms amounted to **43 million 645 thousand**, of which 14 million 742 thousand were recorded in the fourth quarter of 2021 (+47%).

In the fourth quarter of 2021, 2 million 569 thousand products were sold, up 24% from products sold in the same period in 2020, for a total of **8 million 513 thousand** products sold in the twelve months of 2021, compared to 7 million 497 thousand in the twelve months of 2020 (up 14%).

In 2021 Farmaè S.p.A.'s **Retail** is up **83%** to a total of 4.4 million euros compared to 2.4 million euros in 2020.

"We are very pleased with our Group's growth in the last quarter of 2021. This growth demonstrates the good health of our consolidated business and of the one arising from the new acquisition of AmicaFarmacia, confirming the validity of our strategy. The growth of our Online revenues, of our
